

CONTRACTUAL AMENDMENT NO. 1

Addendum to the ESCROW Agreement between GOUP Entertainment and FREEWAY CAM BV, entered into on January 30, 2024, Florida -USA

BETWEEN:

- I) **EDUARDO NANTES BOLSONARO, Brazilian**, married, federal deputy, bearer of identity card [REDACTED] duly registered with the CPF under No. [REDACTED] resident and domiciled in Brasília, Federal District, hereinafter referred to as **FINANCIER**.

And:

- II) GO UP ENTERTAINMENT LLC, COMPANY WITH REGISTERED OFFICE AT 3901 Nw 79th Ave, Ste 245/4472, MIAMI, Florida, 33166, registered with the Employer Identification Number (EIN) under [REDACTED] represented by its managing partner **KARINA FERREIRA DA GAMA**, Brazilian, married, businesswoman, E-mail: [REDACTED] registered with the CPF under No. [REDACTED] and RG under No. [REDACTED] SSP/SP and by its managing partner **MICHAEL BRIAN DAVIS**, Brazilian with U.S. citizenship, married, businessman, E-mail: [REDACTED] registered with CPF No. [REDACTED] and bearer of RG No. [REDACTED] hereinafter ("Go Up Entertainment");

And:

- III) **FREEWAY CAM BV.**, c/o Piarist köz 2, 1052 Budapest, Hungary, hereinafter referred to as **ESCROW AGENT**.

WHEREAS:

The FINANCIER undertakes to partially finance the film production entitled "Captain of the People", under the management of the production company GOUP Entertainment.

The FINANCIER authorizes GOUP Entertainment, to give Payment/Disbursement instructions on its behalf, to the ESCROW AGENT to make a partial payment to screenwriter Cyrus Nowrasteh, in accordance with disbursement instructions designated by GOUP Entertainment.

By signing this document, the FINANCIER authorizes the use of his/her investment, agreeing to the following risks: a) If the remainder of the funds needed to produce the film is not funded, he/she will not be able to claim the return of this funds once he/she has

authorized its use; b) that in the event of non-capture of the total resources for the production of the Film "Capitão do Povo", in the return of the residual unused investments, this amount cannot be returned because its use was authorized in the initial phase of production without there being profitability yet; c) that you understand that GOUP Entertainment will not be able to reimburse you and that you will not be able to claim any rights from the ESCROW AGENT who, in this transaction, acted only as Custodian and not manager of the Production.

BY THIS ADDENDUM, IT IS AGREED THAT:

1. Payment Terms:

- The FINANCIER authorizes GOUP Entertainment to instruct the ESCROW AGENT, FREEWAY CAM BV., to make a partial payment to screenwriter Cyrus Nowrasteh for the production of the film "Captain of the People."

2. Contract delivery time:

- The contract relating to the production of the script and direction of the film "Captain of the People" must be delivered to the FUNDER by March 1, 2024.

3. Conditions of Non-Conformity:

- If the contract is not delivered by the stipulated date (March 1, 2024), the FINANCIER requests that the amount invested be fully returned to its checking account, the details of which will be provided directly to the ESCROW AGENT.

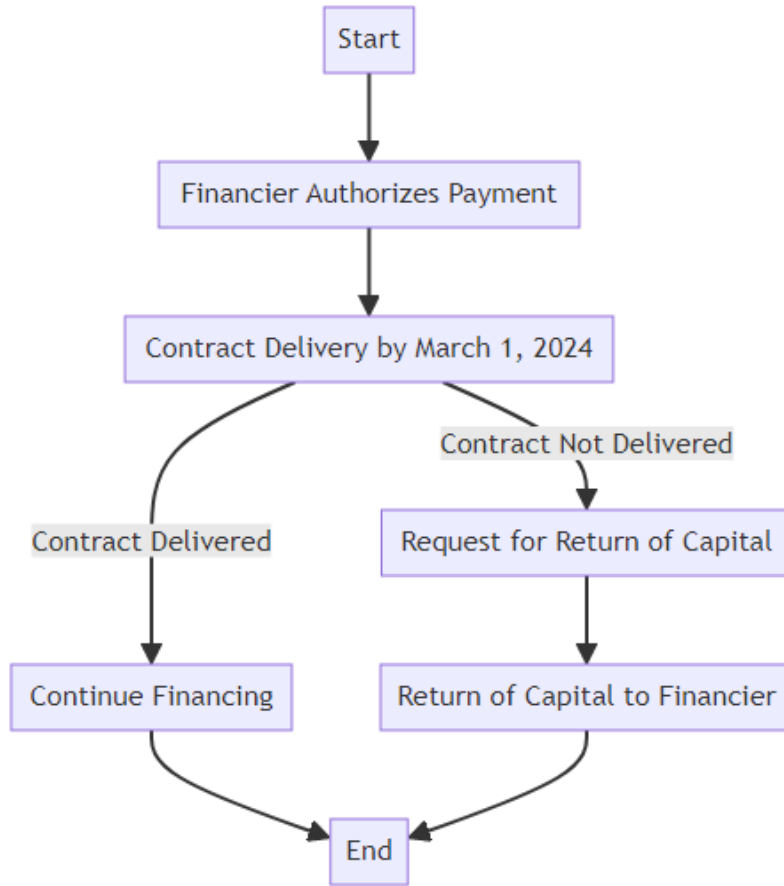
4. Return on Capital:

- In case of non-compliance with the conditions set forth in this amendment, the ESCROW AGENT shall proceed with the return of the invested capital to the FINANCING COMPANY, without prejudice to any losses and damages that may be claimed due to the breach of the contract.
- In the return to the Investor's Account, the ESCROW AGENT is not responsible for the bank fees and exchange costs that are levied on the operation, being the sole responsibility of the investor.

5. Validity:

- This amendment enters into force on the date of its signature and will remain in force until the full implementation of its provisions.
